The Hon'ble Supreme Court by the order dated 19.07.2010 in IA No. 244 in W.P.(C)-1022/1989 (All India Judges Association & Others -Vs- Union of India & Others) accepted the recommendations of Justice Padmanabhan Committee in regard to Sumptuary Allowance, Medical Allowance, Hill Area Allowance/Remote Allowance, Robe Allowance and Domestic Help Allowance and directed all the States to implement the same with immediate effect.

2. After careful consideration of the said direction of the Hon'ble Supreme Court of India and in compliance thereon, the Governor has been pleased to accord sanction for revision of Sumptuary Allowance and Medial Allowance to all the Members of the West Bengal Judicial Services w.e.f. 01.01.2006 as under :

i) SUMPTUARY ALLOWANCE :

SI.No.	Name of the Post	Existing Rate (Per mensem)	Revised Rate (per mensem)
1.	Civil Judge, Junior Division	Rs. 500/-	Rs. 1,500/-
2.	Civil Judge, Senior Division	Rs. 750/-	Rs. 2,300/-
3.	District Judge, All Levels	Rs. 1,000/-	Rs. 3,100/-

ii) MEDICAL ALLOWANCE :

All the serving Officers who are drawing Medical Allowance @ Rs. 100/- per mensem on the strength of the G.O. No. 1313-J/JD/L/25-23/04 (Part-I) dated 17th March, 2006 shall be drawing Medical Allowance at the revised rate of Rs. 1000/- per mensem w.e.f. 01.01.2006.

3. (i) The Sumptuary Allowance and the Medical Allowance at the revised rate shall be paid in cash in the salary bill for the month of October, 2010 payable in November, 2010.

(ii) The differential amount of Sumptuary and Medical Allowance for the period from 1.01.2006 to 31.09.2010 shall be paid in cash by two instalments. The first 60% of arrear is to be paid by 30.11.2010 and the second 40% is to be paid by 31.08.2011.

(iii) The arrears of Sumptuary and Medical Allowance in respect of the Judicial Officers who retired or died or elevated after 01.01.2006 shall be paid in cash in one lump.

- 4. In case of the retired Judicial Officers opting to draw arrears of Sumptuary and Medical Allowance from the District where they are residing after retirement, the District Judge of the concerned District shall act as drawing and disbursing authority for this purpose.
- 5. This order issue with the concurrence of the Finance Department's Notification vide their U.O. No. 3256 dated 21.10.10.

<u>MEMORANDUM</u>

Subject : Revision of Pension/Family Pension, Gratuity Commutation of Pension, Medical Allowance, Domestic Help Allowance of the Members of West Bengal Judicial Service who retired on or after 01.01.2006 as per recommendation of Justice Padmanabhan Committee which had been accepted by the Hon'ble Supreme Court of India with some modifications by the order dated 26.7.2010 in 1A No. 244 in Writ-Petition (Civil) No. 1022 of 1989 (All India Judges Association & Ors. -V-Union of India & Ors.)

The undersigned is directed to refer to the above noted subject and to state that the Governor, after careful consideration of the matter, has been pleased to decide that the retirement benefits in respect of the State Judicial Officers, irrespective of their ranks, who retired on or after 01.01.2006 and whose pay has been revised as per G.O. No. 440//JD/L/2S-70/09 dated 8th July, 2010, shall be determined as under :

A. <u>Pension</u>:

G.O. No. 7012 -J

- A Judicial Officer retiring in accordance with the provisions of the West Bengal (Death-cum-Retirement Benefit) Rules, 1971, as amended from time to time, but before completion of minimum qualifying service of ten years, shall not be entitled to pension, but nevertheless he/she shall continue to be entitled to gratuity.
- Last pay drawn before retirement shall be taken as emoluments for the purpose of calculating pension and the West Bengal (Death-cum-Retirement Benefit) Rules, 1971, shall be applicable in respect of all categories of Judicial Officers of this State.
- iii) With effect from 1.1.2006 linkage of full pension with 33 years of qualifying service as per Memo No. 10771-F dated 29.11.09, shall be dispensed with. Once a Judicial Officer has rendered a minimum qualifying service 20 (Twenty) years, pension shall be paid at 50% of the last basic pay draw. For the Judicial Officers who at the time of retirement have rendered qualifying service for 10 (Ten) years or more but less than 20 (Twenty) years, proportionate reduction shall be made while calculating the amount of pension.
- iv) There shall not be any ceiling limit on the maximum monthly pension payable.
- v) <u>Dearness Relief</u> :

Retired Judicial Officers shall be entitled to get Dearness Relief as sanctioned by the Central Govt. from time to time.

vi) Additional Pension :

Such additional quantum of pension will be payable to the retired Judicial Officers as indicated in the following table w.e.f. 1.1.2006 :

Age of Pensioners/Family pensioners	Additional quantum of pension/family pension
From 80 years to less than 85 years	20% of the basic pension
From 85 years to less than 90 years	30% of the basic pension
From 90 years to less than 95 years	40% of the basic pension
From 95 years to less than 100 years	50% of the basic pension
From 100 years or more	100% of the basic pension

The pension sanctioning authority shall ensure that the date of birth and the age of pensioner is invariably indicated in the single comprehensive Form to facilitate the Accountant General (A&E), West Bengal to record the same in the Pension Payment Order (PPO) to be issued in favour of the pensioners for payment of additional pension by the Pension Disbursing Authority as soon as it becomes due. The amount of additional pension will be shown distinctly in the P.P.O.

vii) Domestic Help Allowance :

Domestic Help Allowance to all the Judicial Officers retired on or after 1.1.2006 has been raised from Rs. 1,250/- per mensem to Rs. 2,500/- per mensem.

The requirement of furnishing certificate by the retired Judicial Officers as per Memo No. <u>1314-J</u> dated 17.3.06 has, however, been dispensed with.

viii) Medical Allowance :

Medical Allowance to the Judicial Officers retired on or after 1.1.2006 to meet the day-today medical expenditure has been raised from Rs. 100/- per mensem to Rs. 1,500/-per mensem. In addition to that the retired Judicial Officers shall continue to enjoy the other facilities with regard to treatment and reimbursement of medical expenditure as per Memo No. 10771-F dated 29th November, 2004.

B. <u>Gratuity</u> :

The payment of Death-cum-Retiring Gratuity and retirement gratuity in respect of the retired Judicial Officers shall be guided by the provisions of W.B. Service (Death-cum-Retirement Benefit) Rules, 1971. The ceiling limit of gratuity is, however, raised from Rs. 2.5 lakh to Rs. 10 lakh w.e.f. 1st January, 2006.

- C. <u>Commutation of Pension</u> :
 - i) A retired Judicial Officer shall continue to be entitled to commute for a lump sum payment upto 50% of his revised pension.
 - ii) The existing table of commutation for pension annexed to the W.B.S. (Commutation of Pension) Rules, 1983, shall be substituted by a new table at Annexure-1.
 - iii) The revised table of commutation value for pension will be used for all commutation of pension, which became absolute after the date of issue of the Memorandum.
 - iv) In case of those pensioners in whose case commutations of pension became absolute on or after the 1st day of January, 2006, but before the issue of this memorandum, the revised table of commutation value for pension will be used for payment of commutation of pension based on pre-revised Pay/Pension. Such pensioners shall have an option to commute the pension that has become additionally commutable on account of retrospective revision of Pay/Pension on implementation of the recommendation of Justice Padmanabhan Committee. On exercising such option by the pensioner, the revised table of commutation value of pension will be used for the commutation of the additional amount of pension that has become commutable on account of retrospective revision of Pay/Pension.

D. Family Pension :

- i) Family Pension shall be calculated @ 30% of the revised Basic Pay last drawn by the pensioner. There shall not be any ceiling limit on the monthly family pension payable.
- ii) Additional Family Pension :

In addition to the Family Pension calculated in Para (i) above, the quantum of family pension available to the old Family Pensioners shall be increased as indicated in the following table w.e.f. 1.1.2006 :

Age of Pensioners/Family pensioners	Additional quantum of pension/family pension
From 80 years to less than 85 years	20% of the basic pension
From 85 years to less than 90 years	30% of the basic pension
From 90 years to less than 95 years	40% of the basic pension
From 95 years to less than 100 years	50% of the basic pension
From 100 years or more	100% of the basic pension

iii) Domestic Help Allowance :

The family pensioners are also entitled to get Domestic Help Allowance @ Rs. 1000/-per mensem w.e.f. 1st January, 2006.

iv) Medical Allowance :

The family pensioners shall also be entitled to get monthly Medical Allowance @ Rs. 750/- per, mensem w.e.f. 1st January, 2006.

v) <u>Dearness Relief</u> :

The family pensioners shall also be entitled to get Dearness Relief as sanctioned by the Central Govt. from time to time.

- E. Mode of Drawing & Disbursing of revision pension/family pension to the Judicial Officers who retired on or after 1.1.2006 but drawing pension/family pension at the pre-revised rate :
 - i) All the treasury officers disbursing pension to the retired Judicial Offices/family pensioners at the pre-revised rate are hereby authorised to pay revised pension/family pension etc. to the existing pensioner/family pensioners at the revised rates as shown in Annexure-II without any further authorisation from the Accountant General (A&E), West Bengal. The Accountant General (A&E), West Bengal will issue authority for this payment to all public sector banks in Kolkata and also to the Accountant Generals of other States.
 - ii) A suitable entry regarding the revised pension/family pension and other benefits shall be made by the Treasury Officers in both halves of the Pension Payment Order. To facilitate the act of entering necessary changes in the pension/family pension and other relief in both halves of the Pension Payment Order, the concerned pensioner shall submit his P.P.O. book to the treasury/public sector bank in Kolkata as the case may be and intimation regarding disbursement of the revised pension and other relief may be sent to the treasury officers to the public sector bank in Kolkata to the accountant General (A&E), West Bengal who issued the P.P.O. in the form given at Annexure-III to this Memorandum to enable the latter to update the P.P.O. register maintained by them.
 - iii) The revised pension / family pension as worked out in Columns 5 & 6 of Annexure-II shall be treated as final basic pension/family pension w.e.f. 1.1.2006 and shall qualify for the grant of relief on pension/family pension sanctioned thereafter.
 - iv) The amount of gratuity, if any, paid earlier to the Judicial Officers, who retired on or after 1.1.2006, according to the Rules prevailing at the material time will be adjusted against the revised gratuity calculated on the basis of the revised emoluments, i.e. last pay drawn by the pensioner, subject to the maximum ceiling of Rs. 10 lakhs. The pension sanctioning authority will make the revised calculation and send the revised calculation of the gratuity showing the adjustment to the Accountant General (A&E), West Bengal for authorisation of payment of the balance amount of gratuity. This exercise has to be completed within two months from the date of issue of this Memorandum so that payments of arrears may be completed by 31st March, 2011 as per the direction of the Hon'ble Supreme Court of India.

- v) The option for commutation of pension as referred to in Para-C of this Memorandum shall be exercised within one month from the date of issuance of this Memorandum before the Pension Sanctioning Authority.
- vi) The arrears of pension, gratuity and other relief from 1.1.2006 till the date of actual revision shall be paid by one instalment. If any pensioner/family pensioner has expired during this period the arrear pension shall be paid to his/her nominee(s) or in case if there is no nomination to his/her legal heir(s).

The undersigned is directed to refer to the above noted subject and to state that the Governor, after careful consideration of the matter, has been pleased to decide that the retirement benefits in respect of the State Judicial Officers, irrespective of their ranks, who retired prior to 01.01.2006 shall be determined as under:

2. (i) The revised pension of the Judicial Officers who retired prior to 01.01.2006 shall be 50% of the minimum pay of the revised pay scale of the post held by him at the time of the retirement as shown in the Table below :

- (ii) There shall not be any ceiling limit on the maximum pension benefit.
- (iii) The Dearness Relief shall be at the rates as are applicable to the serving Judicial Officers at Central Government rate.
- (iv) The Family Pension shall be revised and re-fixed at 30% of the minimum pay of the pay scale of the post held by the pensioner at the time of the retirement in the revised pay scales given in the above Table.
- (v) The Judicial Officers who retired prior to 01.01.06 and the Family Pensioner shall also be entitled to Domestic Help allowance @ Rs. 2,500/- and Rs. 1,000/- per mensem respectively.
- (vi) The Judicial Officers who retired prior to 1.1.06 and the family pensioners shall also be entitled to Medical Allowance @ Rs. 1,500/- and Rs. 750/- per mensem respectively to meet their day to day medical expenses in addition to other medical facilities with regard to treatment and medical expenditure as per memo no. 10771-F dated 29th November, 2004.
- (vii) In addition to the pension/family pension calculated in para (i) and para (iv) above, the quantum of pension/family pension available to the old family pensioners shall be increased as indicated in the following table w.e.f., 1.1.2006 :

Age of Pensioners/Family pensioners	Additional quantum of pension/family pension
From 80 years to less than 85 years	20% of the basic family pension
From 85 years to less than 90 years	30% of the basic family pension
From 90 years to less than 95 years	40% of the basic family pension
From 95 years to less than 100 years	50% of the basic family pension
From 100 years or more	100% of the basic family pension

- 3. The revision in pension shall come into effect from 1.1.2006 and will be applicable to the Judicial Officers who have retired or ceased to be in service due to death prior to 1.1.2006.
- 4. In respect of all the retired Judicial Officers and Family Pensioners all the Treasury Officers / Other Pension Payment Authorities like Bank shall revise and re-fix the pensions and Family Pensions sanctioned in this order on receipt of necessary certificate in this regard from the Pension Sanctioning Authority and after making necessary entries in the Pension Payment Orders make payments to the retired Judicial Officers and Family Pensioners without awaiting further authorization/instructions from the Accountant General (A&E), West Bengal. The Pension Sanctioning Authority shall, on the application of pre-2006 pensioner/family pensioner issue certificate stating the pay scale of the post held by the pensioner at the time of his/her retirement. The revised pension together with dearness relief and other allowance shall be paid in cash w.e.f. 1.1.2006 by 31.3.2011.
- 5. In the event of death of pensioners or Family Pensioners the arrears of Revised Pensions and Family Pensions together with Dearness Relief shall be paid to his or her nominee(s) and if there is no nomination to his/her legal heirs.
- 6. This order issues with the concurrence of the Finance (audit) Department vide their U.O. No. 3255 Group-P (Service) dated 21.10.2010.
