1	Sree Ramkrishna Computer	1. Cancelled because it has been clearly stated in the tender bearing no. 826/1/WBJA dated 04.11.2016 that audited profit and loss Accounts and balance sheets are needed for three years, 2013-14, 2014-15 and 2015-16. But Sree Ramkrishna Computer uploaded unaudited profit and loss accounts and balance sheets. 2. Cancelled because the object clause of trade license of Sree Ramkrishna Computer does not specify that it has been authorized to enter into the trading of water purifiers
2	Dassani Commercial Corporation	Qualified
3	Eureka Forbes Ltd.	Qualified
4	Emphasis	Qualified
5	Lumen Telesystem Pvt. Ltd.	1. Cancelled because the object clause of trade license of Lumen Telesystem does not specify that it has been authorized to enter into the trading of water purifiers.
6	Krona Liquech Ltd.	Cancelled because it has been clearly stated in the aforesaid tender that after sale service must be provided by the vendor, during and after the warranty period (one year warranty and 3 years AMC period). But Krona Liquech has its

		registered Office in New Delhi and has not uploaded any papers showing that it has any franchise at Kolkata. It is not technically viable to execute the AMC with Krona Liguattech Ltd.
