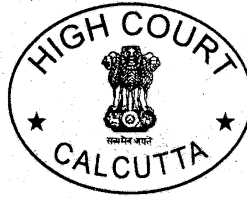

NOTICE

No. 912 - R.G.

Dated: The 17th February, 2020.


WHEREAS, the provisions of the West Bengal Judicial Service (Classification, Control and Appeal) Rules, 2007 and the provisions of the West Bengal Government Servants' Conduct Rules, 1959, as well as other Rules governing the field, enjoin, among other things, that no Judicial Officer or employee shall behave in a manner which is improper and unbecoming of a public servant and derogatory to the prestige of the Courts and the judiciary;

AND WHEREAS, soliciting influence of persons who are/were holding high offices or other positions in Government, Judiciary or otherwise is definitely derogatory to the prestige of the Courts and the judiciary;

AND WHEREAS, any effort made by any Judicial Officer or employee soliciting such extra-institutional interventions amounts to deflecting the due process of administration of justice and interferes with the working of the Courts;

HENCE, all Judicial Officers and employees in the State of West Bengal are hereby notified to ensure that they do not indulge in any such activity except at the peril of facing adverse consequences in accordance with law.

This notice is being issued pursuant to the Order of the Hon'ble the Chief Justice, High Court, Calcutta, dated 12.02.2020.
